AGENDA ITEM: **EXTEND THE EXPIRATION DATE FOR PROFESSIONAL SERVICES CONTRACT 2019-1527, EGUV SPINE ROAD WEST CONNECTION (PHASE 1) RIGHT-OF-WAY PROJECT**

PROPOSED MOTION:

Adopt a resolution authorizing the City Manager to execute Amendment No. 1 to Professional Services Contract 2019-1527 with Gray and Osborne, extending the expiration date to 12/31/2022 at no change to the total contract amount.

KEY FACTS AND INFORMATION SUMMARY:

On July 23, 2019, Council awarded Contract 2019-1527 to Gray and Osborne for Professional Services for the EGUV Spine Road West Connection (Phase 1) Right-of-Way project. (July 23, 2019 Agenda Summary attached.) Under that contract, Gray and Osborne was to perform a sequence of design and analysis work to establish the Right of Way needed for completion of the "Spine road" providing the vehicular and pedestrian connection from 39th Avenue to 44th Avenue internal to the EGUV development. More specifically, Gray and Osborne was to:

1. Survey to establish the horizontal alignment of the roadway and sidewalks on the two parcels (Advent Lutheran and Kim properties) that do not yet have dedicated right of ways,
2. Determine the stormwater storage, treatment, and conveyance needs resulting from the impervious surface created by the future construction of roads and sidewalks.
3. Prepare legal descriptions for parcels that the City would acquire to prepare for future construction.

The adopted schedule was for the project to be complete by July 2020. The Contract has an expiration date of 12/31/2020.

As a result of COVID-19 and other staff capacity issues, the EGUV ROW project was informally suspended in early 2020. The Farm has continued to develop west of the project limits, so staff asked Gray and Osborne to re-engage on this project last fall with the purpose of verifying the general stormwater needs for the Spine road. Specifically, as the Farm site foundations and utilities were placed, it became apparent that conveyance through the Farm development would be the critical path for stormwater conveyance from any development (private and public ROW related) from the east. Gray and Osborne has been working with the City and the Farm developer to investigate methods of conveyance of the stormwater coming downslope from 44th avenue to the Vintage and Farm developments, and eventually discharging in the wetlands west of the Farm. That design and analysis

work is in progress; a future report will be presented to Management and Council about their findings and the options available to the City.

The work Gray and Osborne is doing falls under the original contract scope but has extended beyond the original contract expiration date. Staff is seeking Council concurrence to extend the existing contract to a new expiration of 12/31/2022, with no change to the total amount or scope of the contract. The parties will negotiate a revised schedule after the present exploratory investigations are evaluated and a way forward is selected.

CITY MANAGER RECOMMENDATION:

Adopt a resolution authorizing the City Manager to execute Amendment No. 1 to Professional Services Contract 2019-1527 with Gray and Osborne, extending the expiration date to 12/31/2022 at no change to the total contract amount.

TO CONTRACT 2019-1527
CONTRACT FOR PROFESSIONAL SERVICES
EGUV SPINE ROAD WEST CONNECTION (PHASE 1) RIGHT-OF-WAY**

I. Parties

1.1 The Parties to this Amendment No. 1 (“Contract Amendment”) to the Contract for Professional Services, EGUV Spine Road West Connection (Phase 1) Right-of-Way (the “Contract”) between the City of Mill Creek, Washington, a Washington Municipal Corporation located at 15728 Main Street, Mill Creek, Washington (the “City”) and Gray & Osborne, Inc., a corporation organized under the laws of the state of Washington located at 1130 Rainier Avenue South, Suite 300, Seattle, Washington 98144 (“Consultant”), collectively referred to as the “Parties”, and shall be effective upon the execution of the signature of both Parties to the Contract.

Recitals

2.1 The Parties entered into the Contract on or about July 30, 2019.

2.2 Section 4.1 of the Contract included a Completion Date for the Period of Performance of the Contract’s Work of December 31, 2020.

2.3 The COVID-19 pandemic and its impacts prevented the Work from being completed by the December 31, 2020 Completion Date. The Parties agree that the delay due to the pandemic qualifies as circumstance warranting a time extension for completion of the Work as permitted under Section 4.3 of the Contract.

2.4 The Parties desire to extend the Completion Date for the Consultant’s Work without increasing the Contract amount.

IN CONSIDERATION of the mutual benefits and advantages conferred by this Amendment, the City and Consultant agree to the following modifications to the Contract.

Contract Amendments

3.1 Section 4.1, Completion Date, is amended to read as follows:

Consultant shall commence the Work upon the City’s issuance of the notice to proceed and shall complete all Work no later than December 31, 2022 (“Completion Date”), unless extended or terminated earlier by the City pursuant to the terms and conditions of this Agreement. The “Period of Performance” is the period of time between the Effective Date and the Completion Date.

3.2 With respect to Section 4.2, the Project Schedule, the Parties will negotiate in good faith revisions to the dates in the Project Schedule set forth in Exhibit B to accommodate the extended Completion Date.

3.3 Except as specifically modified herein, all other provisions of the Contract shall remain in full force and effect. No additional funds are authorized for the completion of the Work.

WHEREFORE, the Parties represent that each has the authority execute this Contract Amendment.

WEST CONNECTION (PHASE 1) -PROFESSIONAL SERVICES
CONTRACT

PROPOSED MOTION:

Motion to authorize the City Manager to execute a contract with Gray & Osborne, Inc. for engineering and right-of-way services for property acquisition needed for future construction of East Gateway Urban Village (EGUV) Spine Road West Connection (Phase 1) and relocation of existing drainage pond in an amount not to exceed \$118,200.

KEY FACTS AND INFORMATION SUMMARY:

The EGUV subarea plan was designed with internal access provided via a "Spine Road." Several parcels in the East Gateway Urban Village have already built, or are in the process of building, the "Spine Road" within their development. Within the Phase 1 section located west of 44th Ave. SE, right-of-way was dedicated as part of the approval of development for the Gateway Building, the Vintage and The Farm. However, right-of-way has not been dedicated for two other parcels: Rim Kim and the Advent Lutheran Church (Attachment A).

This project is included in the 2019-2024 Capital Improvement Plan (Attachment B) and will complete:

- A) Acquisition of 72 LF of Right-of-way for the "Spine Road" at Rim Kim and Advent Lutheran Church. This means that all right-of-way needs for the roadway from 39th Ave. SE to 44th Ave. SE would be fulfilled.
- B) Possible additional right-of-way acquisition needed to address surface water needs: relocation of the detention pond located at the Advent Lutheran Church parcel and surface water runoff created by the proposed (new) roadway.
- C) Acquisition of a 20 LF pedestrian easement located on the south boundary line of the Rim Kim and Advent Lutheran Church parcels for future pedestrian connectivity throughout the EGUV.

In April 2019, staff contacted four consultants from the Municipal Research and Services Center (MRSC) consultant roster soliciting Request for Qualifications (RFQs) for engineering and right-of-way professional services associated with the Spine Road West Connection (Phase 1). Gray & Osborne, Inc. submitted an RFQ and staff confirmed references from other public agencies. A professional services agreement has been prepared (Attachment C). A summary of the scope of services include:

AGENDA ITEM #B.

- Project Management: Communication with City staff and management of consultant team.
- Survey: Perform ground survey to establish horizontal control with existing monuments and already built roadways, review of title reports and determine invert elevations of existing surface water facilities.
- Surface Water Review and Analysis: Review of drainage reports for EGUV developed properties with the purpose to determine conveyance capacity through these developments. Perform a hydraulic analysis to determine storm water storage and treatment for the proposed 72 LF of right-of-way and existing detention pond at the Advent Lutheran Church property. Evaluate options (underground vaults, ponds, etc.) to determine required right-of-way needs associated with surface water.
- Legal Descriptions: Prepare legal descriptions associated with right-of-way acquisition parcels.
- Right-of-way Services: Tasks will follow the City of Mill Creek Right of Way Procedures approved by WSDOT (Washington State Department of Transportation) - Attachment D. Additionally, the roadway has been classified as an Urban Minor Arterials by FHWA (Federal Highway Administration) –Attachment E. This facilitates future grant opportunities for design and construction.

The engineering and right-of way services are estimated to be completed in July of 2020.

CITY MANAGER RECOMMENDATION:

The City Manager recommends that City Council authorize the City Manager to execute a contract with Gray & Osborne, Inc. for engineering and right-of-way services for property acquisition needed for future construction of East Gateway Urban Village (EGUV) Spine Road West Connection (Phase 1) and relocation of existing drainage pond in an amount not to exceed \$118,200.

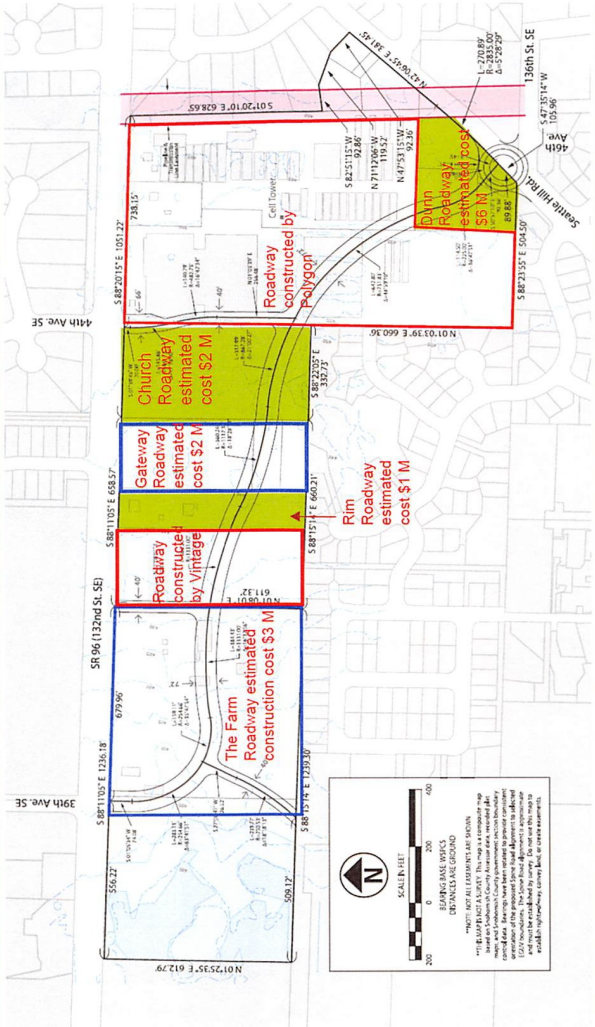

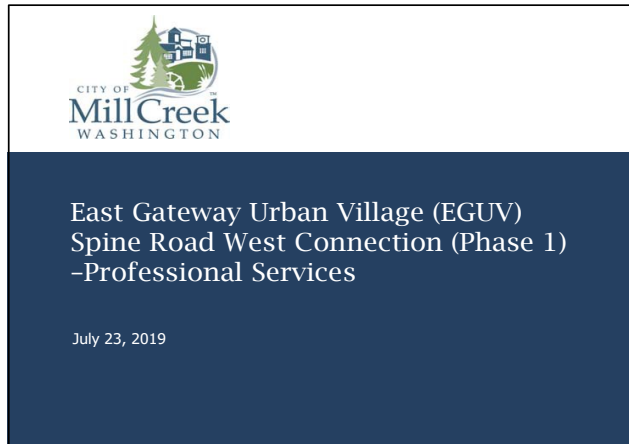

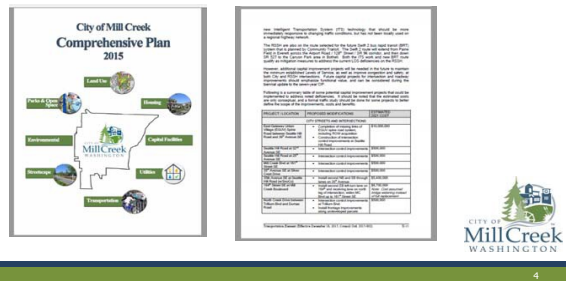

ORDINANCE NO. _____

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MILLCREEK,
WASHINGTON, AMENDING CHAPTER xxxx OF THE MUNICIPAL CODE
AND CRIMINALIZING THE POSSESSION OF A CONTROLLED SUBSTANCE
WITHOUT A PRESCRIPTION.**

WHEREAS, the use of controlled substances without a prescription and the supervision of a medical professional can result in physical injury or death; and

WHEREAS, the use of controlled substances without a prescription and the supervision of a medical professional often exacerbates mental health conditions; and

WHEREAS, using controlled substances can alter a person's brain or brain chemistry. with negative health consequences; and

WHEREAS, persons using controlled substances can become addicted to such substances resulting in negative physical and mental health consequences and damage to family and personal relationships; and

WHEREAS, the use of controlled substances without a prescription or medical supervision is more likely to result in addiction; and

WHEREAS, the use of controlled substances without a prescription is positively correlated with criminal behavior; and

WHEREAS, the City has taken steps to address these problems through teaming police officers with alternative programs, mental health professionals and providers through the court's Mental Health Alternatives Programs; and

WHEREAS, on February 25, 2021, the Washington State Supreme Court held in the case of State v. Blake, No. 96873-0, that RCW 69.50.4013(1) – the statute that criminalized the possession of a controlled substance without a prescription – exceeds the state's police power and violates the due process clauses of the state's constitution; and

WHEREAS, the Supreme Court's ruling has the effect of eliminating any criminal penalties for the possession of a controlled substance without a prescription; and

WHEREAS, the Supreme Court's ruling also eliminates the authority of police officers to arrest persons possessing a controlled substance without a prescription or obtaining search warrants to search for controlled substances possessed without a prescription; and

WHEREAS, the lack of criminal penalties for the possession of controlled substances without a prescription will immediately result in an increase in the negative health and safety consequences associated with the use of controlled substances without a prescription; and

WHEREAS, the lack of enforcement authority of the police will interfere with the City's initiatives to address addiction and criminal activity associated with the use of controlled substances without a prescription by eliminating incentives for individuals to enter treatment or obtain necessary social services; and

WHEREAS, the effect of eliminating criminal penalties and police authority in regard to the possession and use of controlled substances without a prescription will have an immediate, direct, and negative impact on the health, safety, and welfare of the City's inhabitants; and

WHEREAS, this is a public emergency ordinance necessary for the protection of public health and public safety and should be effective upon adoption.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MILLCREEK,
WASHINGTON, DO ORDAIN AS FOLLOWS:

SECTION 1. The Recitals set forth above are adopted as findings of fact in support of this emergency ordinance.

SECTION 2. Chapter 6.27 of the municipal code is amended as set forth in Exhibit A.

SECTION 3. Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

SECTION 4. Upon approval by the city attorney, the city clerk or the code reviser are authorized to make necessary corrections to this ordinance, including scrivener's errors or clerical mistakes; references to other local, state, or federal laws, rules, or regulations; or numbering or referencing of ordinances or their sections and subsections.

SECTION 5. Effective Date. This ordinance is necessary for the protection of public health and public safety and is effective upon adoption.
